**ORDINANCE NO. 01 OF 2020**

**AN ORDINANCE OF THE TOWNSHIP OF SOUTH FAYETTE, ALLEGHENY COUNTY, PENNSYLVANIA, ACCEPTING THE DEDICATION OF A CERTAIN STREET KNOWN AS MANNI WAY IN THE MANNI PLAN OF LOTS SITUATE IN THE TOWNSHIP OF SOUTH FAYETTE, ALLEGHENY COUNTY, PENNSYLVANIA.**

WHEREAS, the Township of South Fayette has heretofore accepted for recording purposes a certain Plan of Subdivision known as the Manni Subdivision Plan, recorded in the Office of the Department of Real Estate of Allegheny County, Pennsylvania, at Plan Book Volume 302, Page 138; and

WHEREAS, the owner of said property has requested the Township of South Fayette to accept the dedication of Manni Way, together with all public improvements, if any, constructed in said street, all as more fully set forth in the description and survey attached hereto and marked as Exhibits "A" and "B" together with and subject to a certain Access and Maintenance Easement for the purpose of support and maintenance of a concrete retaining wall set forth in the above described easement located along easterly property line of Lot 62 R in the above referenced Plan.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF SOUTH FAYETTE AND IT IS HEREBY ORDAINED AND ENACTED AS FOLLOWS:

1. The dedication of Manni Way, as more fully shown in the Plan of

Subdivision known as the Manni Subdivision Plan, recorded in the Office of the Recorder of Deeds of Allegheny County, Pennsylvania at Plan Book Volume 302, Page 138, and as shown in the legal description and Plan, attached hereto, marked as Exhibits "A" and "B" and made a part hereof, together with all public improvements, if any, constructed within said streets, together with and subject to a certain Access and Maintenance Easement for the purpose of support and maintenance of a concrete retaining wall set forth in the above described easement located along easterly property line of Lot 62 R in the above referenced Plan, be and are hereby accepted.

2. The legal description for said street and the Plan identifying the location and description of the street, Exhibits "A" and "B" are incorporated herein and made a part of this Ordinance.

3. The proper officials of South Fayette Township are hereby authorized and directed to do all things necessary to effectuate the purpose of this Ordinance.

4. In the event any provision of this Ordinance or its application to any person, corporation and/or other entity under any circumstances shall be held to be unconstitutional, illegal, or invalid, then the remainder of this Ordinance shall not be affected thereby. In lieu of each clause or provision of this Ordinance which is deemed to be illegal, invalid or unenforceable, there shall be added, as part of this Ordinance, a clause or provision as similar in terms to the unenforceable provision as may be possible and as may be legal, valid and enforceable.


